

GreenCo Annual Rated & Registered Companies




GreenCo Rating Levels

GreenCo Rating Levels - Large Companies









E-GREENCO DURING COVID


The crisis came out of the blue and caught us off-guarded. With the imposition of lockdown, raging pandemic, travel ban and work restrictions, many an industry were stunned into locking their doors, albeit temporarily. GreenCo has the mandate to assist the industries on their green journey, but with the grinding halt which came through lockdown, this journey was seemingly slowed. But with the help from technology, GreenCo took a detour and went into online mode.

COVID Impact on Green

Due to overbearing risks and unimagined halt of production, companies had the task of maintaining their status-quo, for some it meant staying afloat while for some it meant staying relevant. In these uncertain times, it might have appeared that the time-tested strategies and global outlooks went for a toss. While firms had to devise novel ways to capture and create value, one thing which was still a priority was the green business practices and the allied risk of not implementing those.

While more than 70% of the business leaders said their businesses are very exposed to COVID-19 crisis, more than 80% believed that a sustainable business would have been more resilient to such shocks. 




GreenCo Applicability

GreenCo is a facility level rating system, applicable for industries with more than three years of operational data. GreenCo is applicable to all manufacturing and service sectors. As of today GreenCo rated companies are spread across most of the manufacturing sectors - automobile, Cement, Chemical, Engineering, Fertilizer, FMCG, Foundry, Iron & Steel, Pharmaceuticals, Paints, Pulp & Paper, Petrochemical - downstream, Refineries, Sugar, Textile. 
